# XtremeMarkets No Deposit Bonus Terms & Conditions

## 1. Eligibility & Registration

- The No Deposit Bonus is available to new clients who register on XtremeMarkets and complete the necessary verification process.
- Clients must be 18 years or older to participate.
- Each client is eligible for only one No Deposit Bonus account. Multiple registrations by the same individual are prohibited.
- The client must not be related to any other participant in the No Deposit Bonus program.
- The client must register and complete verification by uploading the required documents in the member area (<https://my.xtrememarkets.com/>) or sending them via email to [backoffice@xtrememarkets.com](mailto:backoffice@xtrememarkets.com).
- Account activation may take up to 24 hours after successful verification.
- The No Deposit Bonus will be credited as \$30 trading credit, which cannot be withdrawn.

## 2. Trading Conditions

- The trading period starts on the day the No Deposit Bonus account is activated and lasts for 30 days.
- The maximum lot size per trade is 0.01 mini lot.
- The maximum number of open orders at a time is 5. Clients must close an existing order before opening a new one if they have reached this limit.
- The client must complete a minimum trading volume of 2 standard lots within the 30-day period.
- Only closed trades will be counted toward the required lot volume.
- Trade eligibility conditions:
  - A trade must remain open for at least 2 minutes.
  - The price difference between opening and closing must be at least 2 pips.
  - Trades that do not meet these conditions will not be counted toward the required lot volume.
- Clients can check their total lots in their trading account history at any time. The valid lots will be sent to them once the trading period is over.
- A full report on trading account history and eligibility for profit withdrawal will be provided within 7 days after the end of the 30-day trading period.

### **3. Withdrawal Conditions**

- Profits cannot be withdrawn before the completion of the 30-day trading period.
- To withdraw profits, clients must:
  - Complete the 2 standard lot trading requirement.
  - Maintain an active account for the full 30-day period.
- The maximum profit that can be withdrawn from the No Deposit Bonus account is \$100.
- Any additional balance beyond \$100 will be nullified and cannot be used for trading or withdrawal.
- Internal hedging is not allowed:
  - Clients cannot open both buy and sell positions on the same currency pair at the same time.
- Expert Advisors (EAs) and trading robots are prohibited on No Deposit Bonus accounts.
- Hedging and fraud prevention:
  - Internal or external hedging strategies are not allowed.
  - Accounts found engaging in hedging or using similar trading patterns across multiple accounts may be disqualified at any time.
  - Clients using the same IP address for multiple accounts will be disqualified.

### **4. Disqualification & Account Termination**

- XtremeMarkets reserves the right to disqualify clients from the No Deposit Bonus campaign for any of the following reasons:
- Violation of any company policies, including:
  - Client Agreement
  - Partnership Agreement
  - Bonus Terms & Conditions
- Non-compliance with No Deposit Bonus Terms & Conditions.
- Engaging in dishonest, unfair, or unethical trading practices.
- Collusion with other participants to manipulate results.
- Use of multiple accounts under the same identity or IP address.
- Use of arbitrage or exploitative trading strategies.
- XtremeMarkets retains full discretion to investigate and determine violations. If disqualified, the client forfeits all associated profits and account benefits.

## 5. Withdrawal Process

- Once the 30-day period is completed and the trading requirements are met, eligible profits will be transferred to the client's XtremeMarkets Wallet.
- Clients may choose to either continue trading with their profits or withdraw funds.
- Identity verification is mandatory before withdrawals. The process includes:
  - Account manager verification
  - Call verification
- The wallet name and withdrawal account name must match for the withdrawal to be processed.
- Withdrawals will be processed only after all eligibility checks are completed.

## 6. General Terms & Conditions

- XtremeMarkets reserves the right to modify, suspend, or terminate the No Deposit Bonus campaign at any time without prior notice.
- Participation in this campaign is subject to all standard trading policies and regulations enforced by XtremeMarkets.
- XtremeMarkets is not responsible for delays, technical issues, or disputes arising from third-party payment providers or trading platforms.
  - By participating in this campaign, the client agrees to the full Terms & Conditions outlined above and acknowledges that non-compliance may result in disqualification.
  - The NO deposit bonus account is only eligible for African Region
