XtremeMarkets Tradeable Bonus Account Terms & Conditions

Bonus Structure & Deposit Limits

- Bonus Type: 100% Tradeable Bonus
- Minimum Deposit: \$100
- Maximum Deposit per Transaction: \$2,000
- Maximum Total Deposit Allowed: \$10,000
- Bonus Eligibility: Bonuses are eligible on all deposits. Every redeposit qualifies for a 100% Bonus.
- **Re-deposit Rule:** If a client deposits a second time, they receive a 100% bonus again, and the previous pending lot requirement is carried forward.
- Lot Requirement Calculation: Traders must complete 20% of the deposit amount in lots to withdraw their initial deposit + profit.
- Bonus Time Frame: The bonus period starts from the day the deposit is made and lasts for 60 days.

Lot Completion & Withdrawal Conditions

- Full Withdrawal Condition:
 - o To withdraw initial deposit + full profit, a trader must complete 20% of the deposit amount in lots.
- Partial Profit Withdrawal Based on Lot Completion:
 - o If 25% of required lots are completed: Can withdraw 25% of profit, but initial deposit remains locked.
 - o If 30% of required lots are completed: Can withdraw 30% of profit, but initial deposit remains locked.
 - o If 100% of required lots are completed: Can withdraw initial deposit + full profit.
 - o If the bonus period ends and the trader has only completed 60% of the required lots:
- They can withdraw 60% of their profit, but the remaining profit is removed.
- Their initial deposit + 60% profit will be transferred to their wallet.

General Terms & Conditions

- The bonus is only available for trading and cannot be withdrawn directly.
- If a trader requests a withdrawal before meeting the required lots, the bonus will be removed.
- If we detect **multiple wallets with the same IP**, the **bonus will be canceled**, and all **profits will be removed**. The client will only be able to withdraw their initial deposit.
- If we detect internal hedging (trading opposite positions between accounts), the bonus and all profits will be canceled. The client will only be able to withdraw their initial deposit.
- The company reserves the **right to cancel or modify** the bonus program at any time.
- If any abuse, **fraud**, **or violation** of terms is detected, the company has the right to **revoke the bonus and profits earned from it**.
- All trading activities are subject to the company's risk management policies.
